The request came from the non-partisan Fairfax Local Action Group for OneVirginia2021. Our "ask" in purple ink and stars was to encourage those voters to vote "YES" on the Nov ballot for the "Redistricting Commission Amendment". The Bill addresses the many inequities in our voting district lines. This amendment will give VA a transparent, bipartisan, citizen-led commission for fair voting maps. A letter of appreciation was received acknowledging our branches' participation as they reached their 3,000 postcard goal.

### Public Policy and Lobby Corps - Mary Zane and Judi Polizzotti Co-Chairs

On Sunday July 26, Director of Public Policy and Legal Advocacy, Kate Nelson presented recent changes, current status, and future plans.

- Economic Security passage of Equal Pay Act which passed the US House Of Representatives in 2019 but is stalled in the Senate.
- Education AAUW has enjoined in a lawsuit against the Title IX new rules promoted by Secretary Of Education, Betsy DeVos, that allows victims to be cross-examined, includes additional barriers and is being implemented in this time of a pandemic.
- ERA passed in 38 states, we will continue to work towards ratification.
- Others Reduce student loan debt, improve child care, and retirement security.

We are striving to not be the same but have a new normal to serve all. To achieve the goals stated below, we must build coalitions with groups with different perspectives on issues.

- We support the Voting Rights Advancement Act which has an emphasis on grassroots organization and eliminating restrictions on people of color and women.
- Voter education is an important vehicle for change with Voting User Guides and Voter Issue Guides in key races available on action alerts. Mail-in voting education and changes in voting procedures are also important parts of this election.

Madison Roberts, UVA Graduate with a Masters in Public Policy, presented her capstone project on legislation to reduce gender based wage gap in Virginia. She analyzed state gender pay equity legislation and compared options to achieve pay equity. Her recommendation is that the salary history ban legislation is most effective in this effort. It was also mentioned that Virginia state agencies are now not asking for salary history on job applications.

Our Virginia State Public Policy Co-Chairs are Denise Murden and Susan Burke who will provide the VA activities for the upcoming year. They suggested communicating through email and social media to provide the VA priorities to our members and coalition partners. Possibly to also include virtual town halls to address the community.

Thought provoking and encouraging to take action, today's AAUW leadership meeting focused on diversity, equity, and inclusion. I am sitting here thinking what I can do, and what we as the Reason/Herndon branch can do to make a difference.

Dr. Janice Underwood reviewed what she and Governor Northam are working on to increase equity in the state. She emphasized the unique nature of her role - reporting directly to the Governor.

After Dr. Underwood's talk was stopped because of technical problems, her special assistant, Alaysia Hackett, spoke. She discussed several important events and concerns:

--Governor Northam announced a grant opportunity for small business and non-profits that were not helped by the CARES act. Many of these businesses are minority or women owned. The grants will help these businesses survive during the Covid-19 pandemic.

--In March the Health Equity Working group (Virginia was the first state to do this) looked at the disparate impact of Covid on communities of color-including Hispanic groups and undocumented people who have no insurance. The working group is planning so they can respond appropriately to whatever happens in the Commonwealth and that all Virginians have access to appropriate healthcare.

--Alaysia encouraged all of us to key into the website where we can receive updates of all decisions regarding diversity and inclusion on the state level. The website is governor@virginia.gov/diversity.

The next speakers were Angela HatteryPh.D and Earl SmithPh.D who wrote "Policing Black Bodies: How Black Lives are Surveilled and How to Work for Change."

They began the talk with some history and the decision at the US's formation enslaved people were to be considered property and therefore deprived of rights. They also discussed Thomas Jefferson's reneging on his much publicized decision to free his slaves, which he did not do. That Blacks in this country are surveilled in many situations, which causes the heightened numbers in the criminal justice system.

When asked what AAUW could do-what we could focus on- the authors encouraged us to read their book. "Policing Black Bodies" and "Life on the Color Line" by Dr. Gregory Williams: The true story of a white boy who discovered he was black. They also said we could focus on influencing lawmakers about the following concerns:

#### Food Stamps

Raise the limit and make the rules sensible on Food Stamps. Dr. Hattery—under \$5 for a single person. Their reaction was that living on that amount is impossible. DrHattery suggested we ask our members to try to live the present \$5 for food for a single person

Decriminalization of Using Drugs when Pregnant.

White women addicted to opiod use are sent to rehab. Black woman addicted to crack are sent to prison. The authors discussed the outrageous way black women have pregnant women addicted to alcohol or drugs should be given treatment—not incarceration.

Anti-ShackleingLaw—Women prisoners are sometimes shackled in labor and delivery. The reason is the fear they are flight risks—during labor and delivery. Shackleing is cruel and not at all necessary.

#### SPOTLIGHT ON Gail Osberg - Branch Record Holder



Gail Osberg holds at least two branch records – for the most years as a member of AAUW and the most different AAUW positions held.

"I joined the Westchester County, NY branch right out of college in 1959. I had learned about AAUW from the dean of students at SUNY Geneseo who said it was an important organization to get involved in."

But soon she took a break from AAUW due to a series of major events: graduate school, a new job as a librarian at the CIA which meant moving to northern Virginia, marriage, and the birth of a son. When the family moved to Reston, she joined our branch in 1972, which had been founded just three years earlier.

"Almost immediately, I was asked by the president if I would take on the branch newsletter, which I did, and I served as president from 1973-75."

In 1978, Gail was elected corresponding secretary of the VA AAUW State Board and in the early 1980s, she was appointed the Board's technology chair.

"The national AAUW officers realized the importance of computers and held a week-end meeting in San Francisco of the 50 state technology chairs. We spent two full days learning about computers and how to pass on the information to branch members in our state."

Also in the 1980s, for several years Gail was the Reston branch representative to the AAUW Education Watchdog Committee, which closely watched the Fairfax County school system.

"We met monthly, and we testified at the budget hearings of both the school system and the county."

And Gail attended many national AAUW conventions, then held every other year in a different city. A highlight was the one in Boston in 1981, celebrating AAUW's 100<sup>th</sup> anniversary.

"It was attended by hundreds of members and the keynote speaker was Senator Edward Kennedy."

Gail had a lot more in her life than AAUW. Her husband, Tom, worked for the federal government and they had two sons. She was a stay-at-home mom for 9-1/2 years, then in 1978 became a librarian in Fairfax County libraries, first at Pohick Regional Library in Burke, then at Reston Regional, and finally as manager of the Patrick Henry Library in Vienna. The last position included supervising the remodeling of a building and moving into it, a huge job.

After retiring in 1998, Gail became even more active in AAUW. In 2000 she was elected to the State Board again, this time as the Northern District Representative, which meant planning an annual meeting for all members in the district's 12 branches, and meeting quarterly with branch presidents from Fairfax, Arlington and Prince William counties. And she served on the planning committees for two state conventions, including the one at the Dulles Hyatt in 2016.

Gail's husband died in 2001. In 2017 she moved to an assisted living residence in Falls Church, near one of her sons, and she can no longer attend our branch events. But she remains a member and said she "continues to support AAUW as much as possible."

Why is she such a strong supporter of our organization?

"One reason is that it helped me advance professionally, as I could deal with the general public because I had learned to work with different people in AAUW. And I am still very interested in AAUW's goals. Even though I have sons and no daughters, I know how terribly important equality is for women." Written by Marilyn Silvey
